

TOPS at Spar Competition Rules - Flying Fish Flavoured Beer Promotional Competition - Superbalist Vouchers

- 1 This promotional competition (“competition”) is organised by The SPAR Group Limited (through its TOPS at SPAR stores) and The South African Breweries (Proprietary) Limited (“the promoter/s”).
- 2 The competition commences on 25 October 2016 and ends on 25 November 2016 (“competition period”).
- 3 For the purpose of this competition “customer” or “you” means the natural person who participates in this competition.
- 4 Your entry into the competition means that you agree and understand that you are bound by all the competition rules, and that you will only stand a chance to win a prize and that there is no guarantee that you will be receiving any prize.
- 5 You will be entered into the competition after you have purchased 12 or more Flying Fish 440ml CANS or 330ml NRBs from any participating Tops at Spar store during the competition period, and dropped your completed till slip showing that purchase (complete with full name and contact details) into the lollipop stand provided in-store. Only original, properly completed till slips reflecting the purchase of the required number of Flying Fish, and found in the lollipop stands in participating stores at the end of the competition period will be valid entries and entered into the random draw. Valid entries will be collected from all participating stores and will be included in the random draw.
- 6 The winner/s will be randomly drawn/selected from valid entries for the relevant period, one week after the closing date of the competition. An independent third party will randomly select the winner(s). In order to be eligible for the prize, the Winner will be required to be in possession of a valid South African identity document or driver’s licence to prove identity and age over 18 years old.
- 7 There will only be one winner of the Prize in this competition: The prize consists of two Superbalist vouchers, each to the value of R20 000.00 (twenty thousand rand), which may redeemed only via the Superbalist online shopping website during the validity periods stated on the vouchers. The vouchers will be delivered electronically to the winner on the email/cell number owned and provided by the winner and verified by the promoter.
- 8 All terms and conditions of Superbalist vouchers will apply to the prize – see https://superbalist.com/terms_and_conditions.
- 9 The value of the prize includes VAT, and the goods will be given to the winner at the ruling price which is available to any customer on the day that they are rung up at the till.
- 10 The winner/s of the prize/s will be notified by Promoter on the contact details provided on the valid Till Slip within approximately 2 weeks of the competition closing date. If the winner’s contact number/s is/are repeatedly engaged, just ring/s or go/es to voicemail for a period of 7 (seven) days after the random draw, Promoters reserve the right to re-draw a new winner and the previous winner will forfeit the prize without claim against the Promoters.
- 11 In the event of forfeiture of any prize/s for any reasons whatsoever, the winner/s and any other person/s will have no claim against the Promoters, their associates or agents for such forfeiture.

- 12 Once the winner has been contacted and verified, their details will be published on the Promoters' websites. The winner/s may also be requested to participate in marketing activities, but the winner may decline to do so.
- 13 Any costs or expenses incurred in respect of items not specifically included in the prize/s are for the winner's own account. Promoters and their associates, will not be responsible for any other expenses which the winner/s may incur as a result of their acceptance and/ or use of a prize, whether foreseen or not.
- 14 The vouchers are not transferrable and may not be deferred, changed or exchanged for cash or any other item/s.
- 15 Promoters reserve the right to vary, postpone, suspend, or cancel the competition and any prizes (which have not yet been subject to a draw), or any aspect thereof, without notice at any time, for any reason which Promoters reasonably deem necessary.
- 16 In the event of a dispute, the decision of the competition judges is final and binding and no correspondence will be entered into.
- 17 If the winner/s fail/s to comply with any of these rules or the terms of acceptance of the prizes, or if they refuse to sign the Promoters' winner/s declaration or prize acceptance form, this will be construed as a rejection of the prize and then, without prejudice to any other remedy which Promoters and their respective associates or agents may have, the winner will be automatically disqualified and will forfeit the prize without any claim against the Promoters.
- 18 **Indemnity:** Subject to applicable law, you indemnify the promoters, and their respective associated companies (directors, officers and employees) and agents, against any damages that anyone may suffer as a result of, or in any way related to, participation in this competition, and/or the prizes or of this competition, including consequential and economic loss.
